Use this form to apply for a transfer of your KiwiSaver savings if you have permanently emigrated to Australia. You will be eligible to transfer your KiwiSaver savings to an Australian complying superannuation fund if you have left New Zealand to live permanently in Australia and the Australian complying superannuation fund you are transferring to accepts your transfer.

We will also require you to complete an identity verification form, AML Form for an Individual (Form 1), which is available on our website www.nzfunds.co.nz > KiwiSaver > Documents > Member Forms.

#### 3. Acknowledgement and statutory declaration

I apply to the Manager of the Scheme to withdraw the balance of my KiwiSaver account and understand that:

- a withdrawal of my KiwiSaver account balance in the case of permanent emigration is subject to the Manager's approval; and
- before my application is approved I am required to:
  - complete the statutory declaration below;
  - provide proof of the date I left New Zealand (e.g. copies of airline tickets, passport, other documentation showing departure); and
  - provide evidence of my residential address in Australia (e.g. utility bill, bank statement, etc).
- I understand the information provided in connection with this form will be used by the Manager, the Administration Manager and the Trustee (including their related entitites) to process my transfer request (and may be disclosed for these purposes to third parties where relevant, including my Authorised Financial Adviser, Inland Revenue or other government agency). I acknowledge I have the right to access and correct this information subject to the provisions of the Privacy Act 1993.
- I understand that any information I give to the Manager may be passed on to my chosen Australian superannuation fund as reasonably required and I authorise the Manager to give such information in relation to this transfer as is requested by my chosen Australian superannuation fund.
- I acknowledge that there may be tax consequences when transferring my KiwiSaver savings to an Australian superannuation fund, and that I am liable for any such tax consequences. I acknowledge that the Manager has recommended that I seek independent and professional Australian and New Zealand tax advice pertaining to my circumstances in relation to the proposed transfer.
- I understand that my transfer value will be based upon the unit price(s) at the date my request is processed and the exchange rate prevailing when my transfer is made (foreign exchange fees may apply).
- I understand that my NZ Funds KiwiSaver Scheme account will be closed upon my NZ Funds KiwiSaver Scheme savings being transferred to my chosen Australian superannuation fund.
- I understand that following a transfer of my KiwiSaver savings to an Australian superannuation fund, I will not be able to transfer them to a third country.
- I understand that my application will be unable to be processed if my chosen Australian complying superannuation fund named in Section 3 of this application cannot accept the transferred funds.
- I acknowledge that on the receipt of my funds by the Australian superannuation fund, the Manager of the NZ Funds KiwiSaver Scheme will be released from all liabilities in respect of my membership in the NZ Funds KiwiSaver Scheme.
- I understand that the 'New Zealand sourced' savings in my Australian superannuation fund will not be able to be accessed until the age of eligibility for New Zealand Superannuation is reached (currently 65).
- I understand that once my NZ Funds KiwiSaver Scheme savings have been transferred to Australia, they will become (with a few exceptions) subject to the standard rules and regulations governing the Australian superannuation fund.

### I solemnly and sincerely declare that: I emigrated from New Zealand on Dav Month and have been a resident in Australia since Day Month Year and I have had my principal residence in New Zealand for the entire period that I have been a member of KiwiSaver; OR I was living overseas from Day Month Year Dav Month Year to and I understand I do not qualify to be paid the member tax credit for this period.
